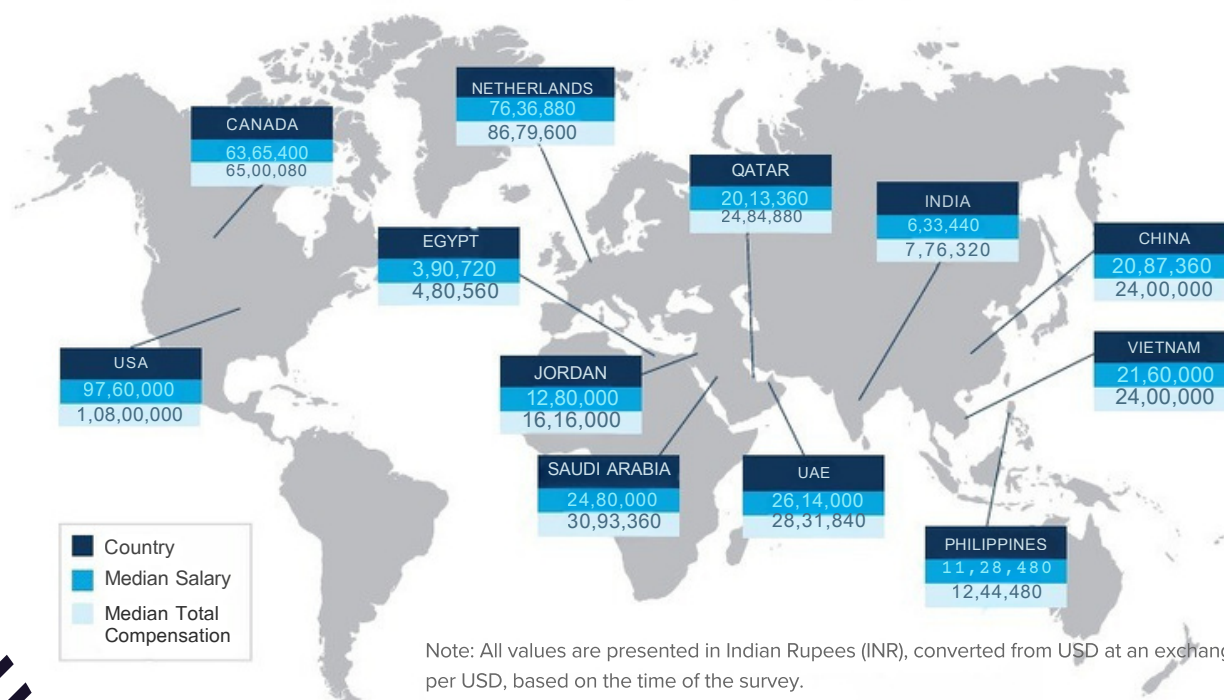

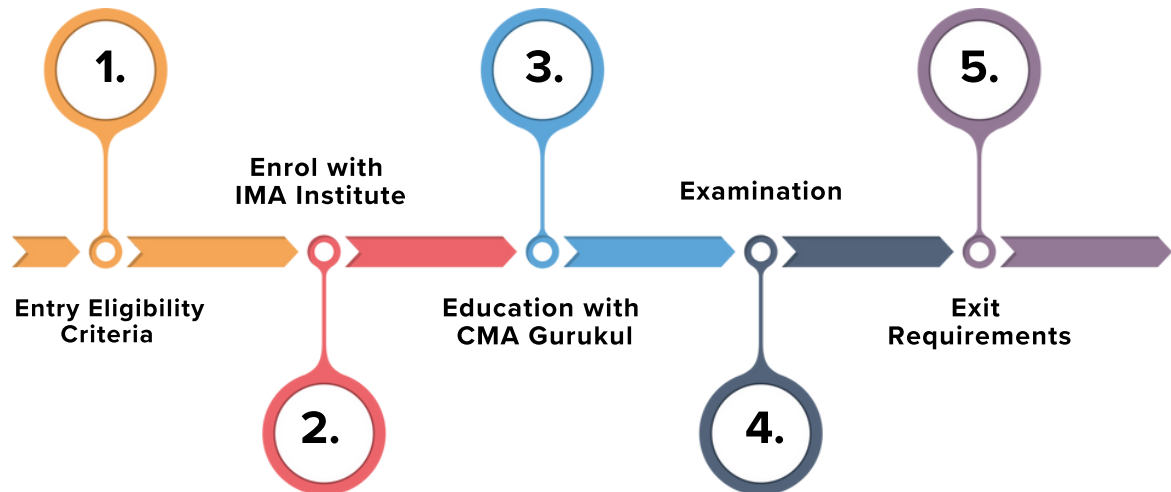

1. Entry Eligibility Criteria

Minimum Education Qualification

A 12th grade student is eligible to enroll for the course

Pro Tip: No minimum pass percentage requirement in 12th std exams and even **NON-COMMERCE STUDENTS** are eligible to enroll.

2. Enrol with IMA Institute

Steps to Create an IMA Account and Enroll as a CMA Candidate

1. Visit the IMA Website

Go to the official Institute of Management Accountants website: www.imanet.org

2. Choose Your Membership Type

3. Complete the Membership Application

- Create your IMA membership account by filling in your personal and professional details.
- Follow the on-screen instructions to successfully complete the application process.

4. Enroll as a CMA Candidate

- Once you become an IMA member, you are eligible to enroll in the CMA program.
- A unique Customer ID will be generated for each CMA candidate upon enrollment

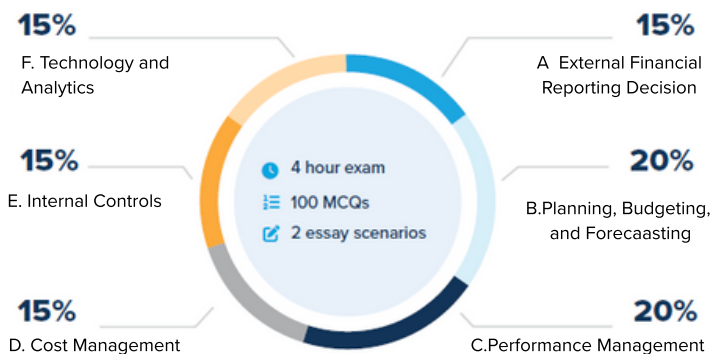

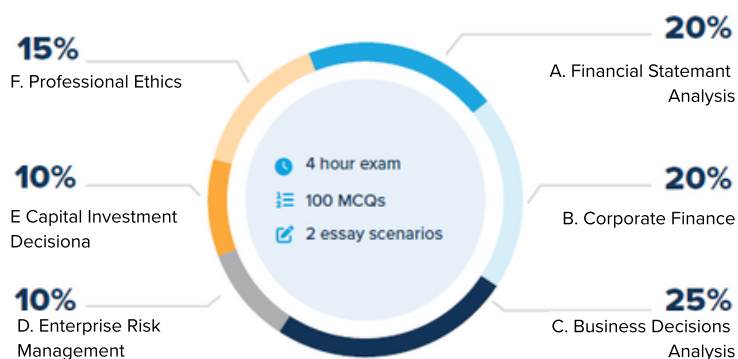

Course Duration: 12 - 14 Months

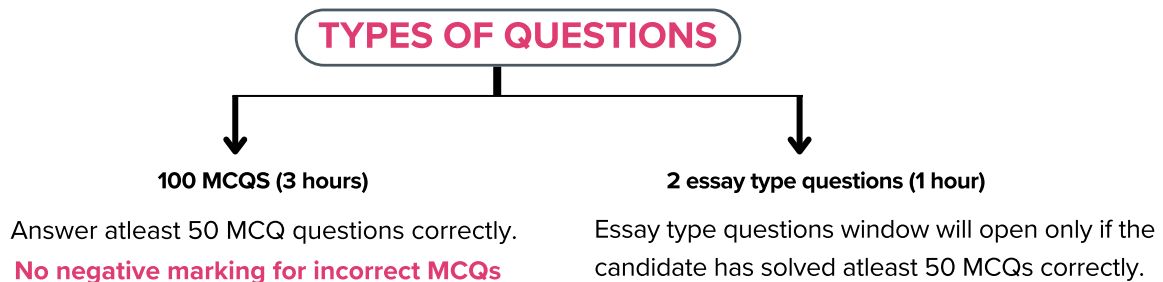

| Testing Windows

- Exams are **computerized** and **on-demand proctored**.
- There are **3 exam windows** each year.
 - Jan-Feb** (Last date to register- 15th Feb)
 - May-June** (Last date to register- 15th Jun)
 - Sept-Oct** (Last date to register- 15th Oct)
- Candidates can **choose their exam date** within the window, subject to **slot availability** at Prometric centers.

For every exam part..

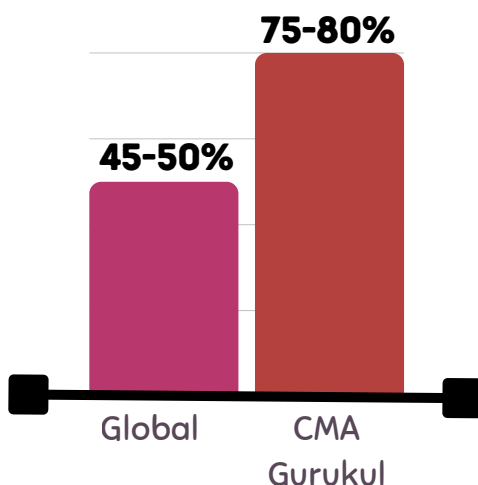


Minimum total passing marks = 360 out of 500 marks i.e. 72%

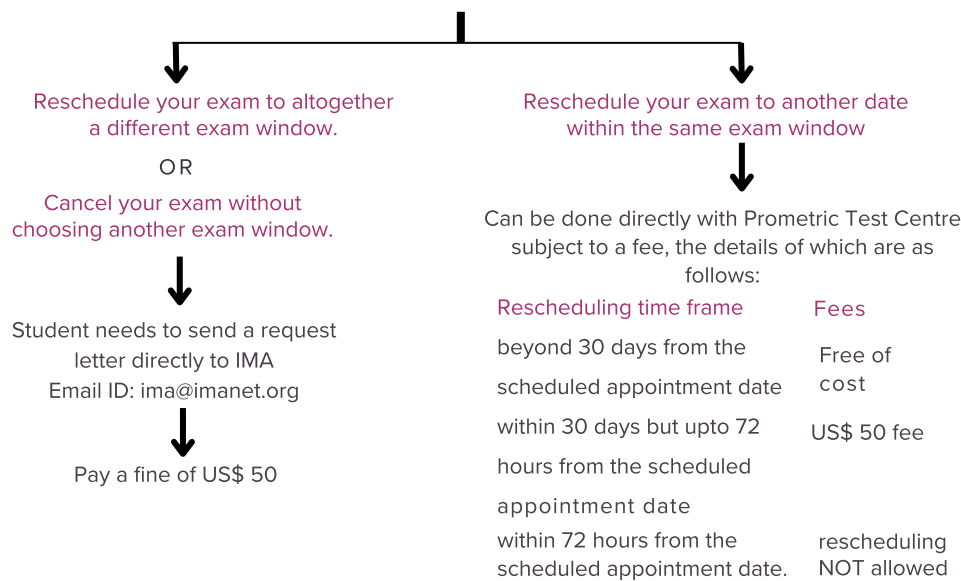
Pro Tip: IMA does not disclose the exact passing criteria beyond the information already provided above

Candidates have a maximum of **three years** from the date of entering the CMA program to **pass both parts** of the CMA exam.

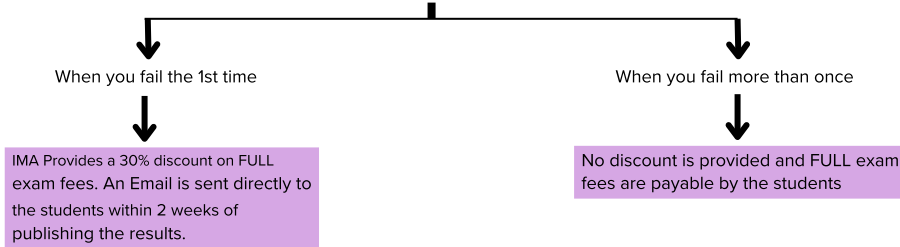

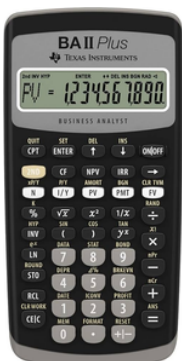

5. Exit Formalities

| CMA US Certification Requirements

Candidates have up to **7 years** after passing the CMA US exam to apply for certification. To be eligible for certification, candidates must **fulfill the following three criteria**:

- **Clear both parts** of the CMA USA examination.
- Submit a **graduate degree** certificate obtained from a reputed university recognized by the Government of India or international authorities.
- Submit a certificate of **2 years of continuous relevant work experience**.

(Pro-Tip: The mandatory **work experience need not be post-qualification**. **Articleship** completed during the **Chartered Accountancy** course is also considered **valid work experience for the CMA US** qualification.)

| Qualifying Work Experience includes:

Qualifying experience involves positions requiring judgments based on the principles of management accounting and financial management. Such roles include, but are not limited to:

- Preparation of financial statements
- Financial planning and analysis
- Monthly, quarterly, and year-end close
- Auditing (external or internal)
- Forensic accounting
- Budget preparation and reporting
- Managing general ledger and balance sheets
- Forecasting
- Company investment decision making
- Corporate financial management
- Cost accounting and analysis
- Risk evaluation
- Management information systems analysis
- Development and delivery of financial systems
- Implementation and management of financial technologies
- Tax accounting, analysis, and planning
- Reporting to the SEC or other governmental regulators
- Strategic planning and strategic management
- Sustainability reporting
- Teaching management accounting or financial management at the college/university level
